DETAILS & TERMS & CONDITIONS OF JR. RESIDENTS (NON-ACADEMIC) ONE YEAR TENURE POST

Interested Indian citizen, who fulfills the essential qualification etc., are invited to participate in this Walk-in-Interview as mentioned above, along-with their application form in the prescribed proforma with copies of all supportive certificate/document and also bring all original certificate/documents, in proof of Age, Qualification/s, Registration and Caste, etc., with a Demand Draft of **Rs.1000/-** (Rupees One Thousand only) for UR/BC & **Rs.250/-** (Two Hundred & Fifty only) For EBC/SC/ST candidate) -Non-Refundable- as cost of application, in favour of "Director, IGIMS, Patna" payable at Patna.

Eligibility Criteria:

1. The candidates should have passed MBBS including completion of Internship or equivalent degree recognized by NMC.
2. Only those candidates who have passed MBBS (including Internship) not earlier than two (02) years before the start date of Junior Resident (Non-Academic) i.e. **28-09-2022** will be considered. It implies that those who have completed MBBS or equivalent course (including completion of residency) on or **between 28-09-2020 to 27-09-2022 only will be considered.**
3. Registration is mandatory before interview.
4. Those candidate/s who have already completed total (One) year of Junior Residency either at IGIMS Patna or out-side will not be considered.
5. For all eligible candidates, maximum one terms are allowed. If anyone join and leaves at any time it will be counted as one term irrespective of duration of work.
6. **Work experience in Armed Forces, Central/State Health Services and Private Nursing Homes will be taken as equivalent to Junior Residency (Non- Academic).**

Reservation of Posts :

1. The reservation for BC/EBC/SC/ST/EWS & Female candidates is as per Bihar Govt. rules and 4 % for PWD including OPH candidates (on horizontal basis.)
2. For BC/EBC candidate: Candidates must attach certificate valid for the posts under prescribed by the Government of Bihar which mentions that the candidate does not belong to Creamy Layer. Date of issue of Certificate should not earlier than 01 years from the date of interview for Junior Residency which is **27-09-2022** i.e. should not have been issued before **28-09-2021**.
3. EWS certificate for Junior Residency should have been issued after **01-04-2022** till date of interview i.e. **27-09-2022**.
4. FOR SC, ST, EWS & PWD - certificate should be issued by authorities prescribed by Govt. of Bihar.

NOTE:

In-case of unavailability of eligible FEMALE candidate (Where applicable) MALE candidate may be considered & In-case of unavailability of eligible EWS candidate (Where applicable) Un-reserved candidate for respective Department, may be considered:

Document to be attached:

1. Application Fee in the form of Demand Draft of Rs.1000/- (Rupees One Thousand only) for UR/ EWS/BC candidates and Rs.250/- (Two Hundred & Fifty only) For EBC/SC/ST candidate) **-Non-Refundable-** in favour of "Director, IGIMS, Patna" payable at Patna.
2. Self-attested Copies: Date of Birth Certificate (10th Certificate), MBBS Mark-sheet, Degree, Internship Completion Certificate, Caste certificate (EWS/BC/EBC/SC/ST), PWD Certificate and BMC/NMC registration certificate for verification and also bring the original certificate for verification of certificate without which no candidates shall be permitted to appear for Junior Residency.

Selection Procedure:

1. MBBS graduates will be made on the basis of their aggregate marks in the 3rd Professional MBBS Part-II / Final examinations and based upon merit / interview.
2. The original certificate of the candidate who opt/select for the post of Junior Resident will be retained in the Academic Section of the Institute. The same will not be returned to the candidate before completion of the tenure of the post i.e. 01 (One) year. All original certificates will be returned after obtaining all No Dues from the concerned department/section of the Institute.
3. The selected candidate will be allotted department on the basis of availability of the post in that department, merit-cum-choice and requirement in the Institute.

LEAVE:

1. Junior Resident (Non Academic) are entitled for 2 ½ day leave per completed month of service. Leave will be credited to their account on 15th days of a month.
2. Leave without permission or more than the permitted period will be treated as absentee and will be dealt as EOL, even if leave is due to the JR. Period of EOL will not count towards experience and will not be considering as being within notice period.
3. Ordinarily, leave will be granted for maximum of 05 days in continuity and will be permissible subject to approval of the HOD. Exceptions may be made for medical emergencies at the discretion of the Medical Superintendent only.
4. All leave must be sanctioned prior to proceeding on leave except in medical emergency in which case the HOD must be informed in writing within 48 hours. No leave will be regularized without prior approval of the Medical Superintendent.
5. Absence/ Leave without information of more than 7 days will lead to termination and re-joining of duties will not be accepted during the last month / tenure completion/extended period.
6. **In case candidate wants to quit the Junior Residency mid-way; he/she will be required to give one month's notice or deposit one month's salary, in lieu of notice to the Institute**
7. No leave (except for medical emergencies) will be permitted in the notice period.

DUTIES & RESPONSIBILITIES

Duties and responsibilities of Junior Residents will be fixed by the Institute from time-to-time. They will be required to perform such work as may be needed in the legitimate interest of patient care in the hospital, including emergency duty.

ASSESSMENT

At the end of first 06 (Six) months of the Junior Residency, each Junior Resident will be assessed and in case his/her performance is not found satisfactory, his/her appointment shall be terminated.

GENERAL INSTRUCTIONS

1. Application form can be downloaded from our website www.igims.org. The cost of application form:- Rs.1000/- (Rupees One Thousand) for UR//EWS/BC and Rs. 250/- (Rupees Two Hundred & Fifty) for SC/ST/EBC candidate (Non-Refundable) payable to The Director, IGIMS, at Patna, in the form of Demand Draft. Those who download the application form, from Institute website, shall have to submit a demand draft of Rs.1000/- or Rs.250/- (As Applicable) in favour of Director, IGIMS, payable at Patna.
2. Candidates employed in Government/Semi Government Department or any other employer must submit their application along-with "**No Objection Certificate**" issued by the employer, at the time of interview, otherwise, they will not be considered for interview. In case of not in employment, candidate must submit in writing that they are neither employed in any organization nor doing any course anywhere.

3. Benefit of reservation will be given to Bihar State domicile only and the applicant out-side The State of Bihar will not be entitled for the benefit of reservation. It is requested to bring domicile certificate where applicable. Handicapped person/candidate will be given the benefit of reservation as per rule of Govt. of Bihar. Person working in Govt. Institution shall be given relaxation as per rule.
4. Number of vacancies, in each department may increase or decrease.
5. In addition to Pay + NPA, other allowances will be admissible as per rule.
6. The posts are non-practicing & Private Practice of any kind, direct or in-direct including laboratory, is strictly prohibited and if found indulging in such private-practice, appointment of candidate shall be terminated.
7. Stay in campus is compulsory, if accommodation is provided. If not provided, HRA's admissible as per rule.
8. The Selection Committee's panel will be valid for 06 (Six) months only
9. The Director of the Institute reserves the right to reject/accept any or all the applications without assigning any reason and cancel the advertisement.
10. Canvassing in any form will be a disqualification.
11. No TA/DA is admissible for attending the interview & joining the post if selected.
12. A declaration that whether they have filled-up Declaration form and appeared before the NMC Team for the year 2022-23, for any Medical College or not, should be submitted with the application.
13. Mere selection by the Selection Committee does not give right of appointment to the candidate. The Institute reserves the right of appointment of the candidate/s recommended by the Selection Committee.
